Agenda Item One | Minutes, September 8, 2025:

The Board approved the previous minutes of the September meeting, motion duly made by Trustee Lallier, seconded by Trustee Balcom, and carried.

Agenda Item Two | Bills & Financials:

Motion duly made by Trustee Balcom, seconded by Trustee Lallier, and carried with a 2-0 vote, the Board approved all vouchers on Abstract 05 in the amount of \$63,768.04. Of that amount, \$8,670.04 is being disbursed from the general fund and \$55,098 is being disbursed from the water fund.

Agenda Item Six | County Legislator:

County Legislator Michael Yerdon was absent.

Agenda Item Seven | Joint Waterworks:

The mayor informed the board that by fixing a couple of leaks around the village, the Joint Waterworks noticed a substantial difference in water usage.

Agenda Item Eight | Other Business:

Mayor Haskins updated the snow contract. The Board reviewed and approved of the changes. An example of these changes is to remove the snow around the hydrants to NFPA standards and must be bid by the hour.

Mayor Haskins informed the Board that the previous Mayor Peggy Manchester inquired about hosting the traditional Memorial Wreath hanging outside the Village Office. It will be held on Sunday, November 30th.

Sandy Creek Regional Planning Board needs to have an IMA between the two Villages and the Town to allow the Village of Lacona to be an official part of the Board. Mayor Haskins asked to wait to appoint members until the IMA is completed.

Mayor Haskins wants to create a new Welcome sign for the entry of Lacona to replace the old and faded one. He suggested to have American Aftermarkets design some options for the Board. The Board agreed with that.

Mayor Haskins spoke with Matthew Turcotte of NorthShore Solutions to re-do the Village of Lacona. Mr. Turcotte said it would take about 6-7 weeks for the website to be up and running.

The mayor asked the Board what they thought about going forward with a comprehensive plan grant with Morgan Spencer. It was decided to table this decision for now since Lacona has just joined the Sandy Creek Regional Planning Board.
